1. The following Terms of Service ("TOS") govern the *Foundation of Computer Science* ("FCS™") provision of service to you. The TOS may be updated by us from time to time without notice to you. In addition to the terms found at the preceding URL, when using particular FCS owned or operated services, you and FCS shall be subject to any posted guidelines or rules applicable to such services, which may be posted from time to time. All such guidelines or rules are hereby incorporated by reference into the TOS. FCS may also offer other services that are governed by different Terms of Service.

### 2. DESCRIPTION OF SERVICE

*Foundation of Computer Science* provides users with access to a rich collection of resources, including various communications tools, document processing tools and web publishing tools. You understand and agree that the Service may include advertisements and that these advertisements are necessary for FCS to provide the Service. You also understand and agree that the Service may include certain communications from FCS, such as service announcements, administrative messages and that these communications are considered part of FCS membership. ### 5. MEMBERS CONDUCT

You understand that all information, data, text, software, music, sound, photographs, graphics, video, messages, tags, or other materials ("Content"), whether publicly posted or privately transmitted, are the sole responsibility of the person from whom such Content originated. This means that you, and not FCS, are entirely responsible for all Content that you upload, post, email, transmit or otherwise make available via the Service. 11. "stalk" or otherwise harass another; and/or
12. collect or store personal data about other users in connection with the prohibited conduct and activities set forth in paragraphs above.

You acknowledge that FCS may or may not pre-screen Content, but that FCS and its designees shall have the right (but not the obligation) in their sole discretion to pre-screen, refuse, or move any Content that is available via the Service. Without limiting the foregoing, FCS and its designees shall have the right to remove any Content that violates the TOS or is otherwise objectionable. You agree that you must evaluate, and bear all risks associated with, the use of any Content, including any reliance on the accuracy, completeness, or usefulness of such Content. In this regard, you acknowledge that you may not rely on any Content created by FCS or submitted to FCS, including without limitation information in FCS Message Boards and in all other parts of the Service.
